## Introduction

## Master of Education degree in Higher and Postsecondary Education

The MEd in Higher and Postsecondary Education program at Mary Lou Fulton Teachers College will prepare you to be an innovative leader in higher education. Higher education administration encompasses student and academic affairs, athletics, financial aid, development and fundraising. As a student in this program, you will acquire the foundational content knowledge and skill sets necessary to succeed as an administrator and leader in your chosen area, helping to find solutions to issues confronting contemporary colleges and universities, and gaining the expertise to design and implement those solutions.

This MEd program was created to establish Arizona State University as the model for educating innovative higher education leaders; leaders characterized by:

- A strong foundation in the theory and practice of higher education administration
- The capacity to analyze issues confronting contemporary colleges and universities
- Expertise in designing data-informed solutions to innovate administrative decision-making; and equipped with the necessary tools to promote success among diverse student populations

Course activities and assignments are flexible so you can tailor your learning experience to your career goals. You will learn about:

- The history of higher education in the United States
- Organizational characteristics of colleges and universities
- Important laws and policies pertaining to administrative practice in higher education
- How colleges and universities are funded
- How to successfully work with diverse stakeholders in contemporary higher education
- How to collect and use data to improve decision-making

This program reflects the values and principles of ASU and Mary Lou Fulton Teachers College:

## Purpose of the handbook

This handbook provides guidance and information related to admission, program requirements, and general policies and procedures. Please note that in some cases you will find differences between program policies and requirements and ASU's Graduate College policies and procedures. In these cases, Mary Lou Fulton Teachers College has established higher standards. Policies and procedures are subject to change. Changes will be communicated to students through email. Any updates to this handbook can be found on the <u>program website</u>.

## Admission

Admission to the MEd in Higher and Postsecondary Education program is offered for the fall and spring semesters. Completed admission files are reviewed and admission decisions are made on a rolling basis. Space may be limited; therefore, applicants are strongly encouraged to apply and have all application materials on file with ASU on or before any posted deadlines.

## Graduate admission requirements

ASU maintains *minimum* standards for consideration for admission to graduate programs. The program may establish requirements in excess of those established by the university.

- An earned bachelor's degree or higher from a regionally accredited institution in the U.S., or the
  equivalent of a U.S. bachelor's degree from an international institution officially recognized by that
  country.
- Maintain a B (3.00 on a 4.00 scale) grade point average in the last 60 semester hours or 90 quarter hours of undergraduate coursework. If you do not meet the minimum GPA requirements, your application may still be considered.
- An applicant whose native language is not English must provide proof of <u>English proficiency</u> regardless of their current residency.

## Academic program admission requirements (all program tracks)

In addition to the graduate admission requirements, the program requires the following as part of the application:

Personal statement — This degree program will provide you with a broad-based grounding in the theory and practice of how colleges and universities work, and prepare you to be a leader for success in the higher education enterprise of the future. With this in mind, please describe your personal interest in the field of higher education, the goals you wish to achieve while in the program, and your short and long-term career aspirations once you earn your degree. Specifically, it is helpful for us to learn about which experiences you have had that have informed your interests in higher education and how these experiences have informed your goals/aspirations. The admission committee pays particular attention to the quality of writing in the personal statement, the ideas expressed, and the match between the students' and the program's goals. Your statement should be approximately 500 words (two double spaced pages) and prepared in an MS Word (.doc), Rich Text (.rtf), Portable Document Format (.pdf), or Text (.txt) file format.

**Three professional references** — Provide the names, email addresses and institutions or companies of individuals who will submit electronic letters of recommendation. Your recommenders will be asked to comment on your leadership, professionalism, flexibility and other qualities that indicate you are a suitable candidate for graduate study.

**Resume** that includes relevant personal, professional, educational and community activities (one to two pages). The resume should be prepared in an MS Word (.doc), Rich Text (.rtf), Portable Document Format (.pdf), or Text (.txt) file format.

## Provisional acceptance guidelines

Applicants who do not meet the GPA criteria for admission but have otherwise strong applications may be considered for provisional admission by the committee. This status provides the academic unit with an opportunity to better evaluate the student's academic potential. Students are notified of the provisional requirements in the admission notice from the college.

Most provisions must be completed within the first semester of enrollment. When students have satisfied the provisional requirements, they should confirm with their academic advisor that a change of status has been recommended. Students with provisional admission are not eligible to submit an interactive Plan of Study — the iPOS — until the conditions of admission have been satisfied.

Graduate Admission Services will withdraw students who have not met the provisions of their admission within the required time frame from the degree program.

## Preadmission credit policy

With the approval of the degree program and the ASU Graduate College, students may include a maximum of 12 graduate-level credit hours with grades of B or better that were not used toward a previous degree. Preadmission credits must have been taken within three years of admission to the ASU degree program to be accepted. ## Tuition cost and financial aid

## Tuition and fees

Tuition is set by ASU and the Arizona Board of Regents each year. <u>View the general tuition and fees schedule</u>, or calculate a more specific estimate of charges using the <u>ASU Tuition Estimator</u>. Most online courses carry mandatory fees in addition to tuition and other university fees.

Online tuition for resident students is capped at 11 credits for graduate students. Online tuition for nonresident students is billed per credit hour with no cap.

#### ASU payment plan

If tuition is not paid by the applicable tuition due date, or financial aid is not awarded and accepted by the due date, you will be automatically enrolled in the <u>ASU payment plan</u> and charged a nonrefundable enrollment fee.

## Management internships

Many students seek management intern positions in academic departments, student services, residential life or intercollegiate athletics on one of the ASU campuses. These internships are .50 time (20 hours per week) state employee positions. Visit <u>ASU Human Resources</u> to view posted positions; also consider 25% or 50% time positions listed under "staff."

MI salaries range from \$10,000 to \$17,000 and include health benefits, a retirement plan and a tuition waiver. MI positions are competitive; visit the <u>Careers at ASU</u> page frequently to view up-to-date postings.



## Curriculum and graduation requirements

## Program requirements

Students in the MEd Higher and Postsecondary Education program complete 30 credits in 10 graduate courses, comprising a set of core requirements and three specialization areas: student success, leadership and organizations, and law and finance. Coursework combines theories about how colleges work and how administrators can positively impact students' experiences and outcomes, with practical application of these ideas. In the program's capstone experience, you will implement your newly gained knowledge by designing and performing a small-scale applied research study. You will summarize and present your project in a public poster session akin to those organized for academic conferences.

All courses (with the exception of the practicum) are offered in an intensive 7.5 week hybrid format: 50% of content delivered face-to-face on weekday evenings, 50% delivered through technology-supported or independent learning experiences and fieldwork. Most students complete the program in 15 months. According to the Arizona Board of Regents, an hour of work is the equivalent of 50 minutes of class time (often called a "contact hour") or 60 minutes of independent study work. A minimum of 45 hours of work by each student is required for each unit of credit. Course sequences are found on the MLFTC Graduate Student Resources site.

## Program of study — Downtown Phoenix campus

The MEd program on the Downtown Phoenix campus relies on a cohort model; students take all their courses sequentially with their cohort, either at the Downtown campus or via iCourse. Classes are offered in a mixture of hybrid and fully online formats. Six courses are offered in an intensive 7.5 week hybrid format with half of the content delivered face-to-face on Monday evenings, and the other half delivered online and through independent fieldwork. One course, HED 580 Practicum, meets in person four times during the summer term, and the majority of work occurs in a practice-based setting. The remaining three are ASU iCourses, meeting fully online over a 7.5 week period.

Students in the Downtown Phoenix cohort are not permitted to take program courses in Tempe; all courses in the program must be completed in sequence in downtown Phoenix or via iCourse. The cohort model encourages the development of close working relationships, networks, and cooperative learning among members that extends beyond a single course.

Exact course days and times are subject to change. Refer to the official course schedule. To review course descriptions, visit the ASU Catalog. Students should work with their academic advisor to determine appropriate methods coursework for their content area. Curriculum for all programs is subject to change based on Arizona Board of Regents and Arizona Department of Education updates.



<sup>\*</sup>Practicum course meets face-to-face four times only over the summer. The majority of work for this course occurs in the practicum setting.

## Practicum requirement

The program requires a practical experience, comprising 120 customizable experience hours at a higher education site of the student's choice. The program has had more than 120 partner locations and offices. HED 580 Practicum is a session C course, ideally taken near the end of the program so that course connections can be made. Students can select locations at ASU or other higher education organizations (with permission).

## Culminating experience

The culminating experience for this degree is an action-research applied project. This project is conducted in the HED 593 Applied Project course in the final semester of the program and taken directly after the conclusion of the HED 573 Applied Inquiry. Students work with faculty mentors within these classes to propose and conduct a project in their local context. Students must earn a grade of B or higher in the culminating experience course.

## Interactive Plan of Study

All ASU graduate students are required to complete and submit a plan of study online through the My ASU interactive Plan of Study. The iPOS must be submitted and approved prior to completing 50% of the coursework required for your program.

Students are encouraged to schedule an appointment with their MLFTC advising team to discuss their plan of study and how to complete the iPOS. After submitting the iPOS, your advising team will approve it. The Graduate College has final approval over all iPOS submissions.

When evaluating your iPOS, your advising team will check to ensure all required coursework is included as part of your plan and that you are planning to take courses in the appropriate sequence/order. Your advising team will send your iPOS back to you for revision if it is incorrect.

## Satisfactory Academic Progress and Professional Conduct Policy

In order to remain in good standing in the Mary Lou Fulton Teachers College ("MLFTC"), students must maintain satisfactory academic progress consisting of both Standards of Academic Performance and adherence to the Teachers College Professional Disposition Standards, as described in this policy.

## Graduate College and graduate student responsibilities

Graduate students are responsible for familiarizing themselves with all university and graduate policies and procedures. Each student should also communicate directly with their academic unit to be clear on its expectations for program completion.

Information is provided to students via My ASU. Students should frequently check their My ASU page for the most up-to-date information regarding their status, holds, items to attend to and other important information.



The Graduate College establishes policies that are consistent for all graduate students throughout the university. These policies include, but are not limited to:

- Maintaining continuous enrollment
- Completion of the interactive Plan of Study
- Maximum time limit for completing degrees
- Preadmission credit
- Academic progress
- Graduate degree requirements

## Policies and procedures

## Registration and drop/add policies

All students are required to have proof of measles immunizations on file with <u>Student Health</u> prior to registration. Graduate students register through My ASU according to their enrollment appointment.

Complete details regarding registration and course drop/add procedures are provided in the <u>Registration and Tuition Payment Guide</u>.

## **Enrollment verification guidelines**

The University Registrar's Office will verify student enrollment each semester. Full-time and half-time credit requirements can be found at <u>Enrollment and degree verification</u>.

Note for students in online programs: Typical enrollment in MLFTC online master's degree programs is six credits per semester. This is generally considered half time for enrollment verification purposes. Students beginning online programs in B sessions typically register for three credits in the first term, which is considered less than half time. Typical enrollment in graduate certificate programs is 3–6 credits per semester.

#### Maximum course load

MLFTC provides recommended course sequences for all graduate programs to guide students in their registration each term. Students are encouraged to follow the course sequence for their program or to discuss any alterations with an academic advisor. Course sequences are developed with program progression and student success in mind. The Graduate College does not mandate a maximum course load for graduate students. Anything in excess of 18 semester credit hours requires override approval.

Some MLFTC programs restrict the number of credit hours students may take within their academic program. Please consult your academic advisor if you have questions about your course sequence or the number of credits you may take in any given term.

## Continuous enrollment

Once admitted to a graduate degree or graduate certificate program, students must be registered for a minimum of one credit hour during all phases of their graduate education, including the term in which they graduate. This includes periods when students are engaged in research, conducting a doctoral prospectus, working on or defending theses or dissertations, taking comprehensive examinations, taking Graduate Foreign Language Examinations, or in any other way utilizing university resources, facilities or faculty time.

Registration every fall and spring semester is required. Summer registration is required for students taking examinations, completing culminating experiences, conducting a doctoral prospectus, defending theses or dissertations, or graduating from the degree program.

To maintain continuous enrollment the credit hour(s) must:

- Appear on the student's iPOS, or
- Be research (592, 792), thesis (599), dissertation (799) or continuing registration (595, 695, 795) or
- Be a graduate-level course.

Grades of W or X are not considered valid registration for continuous enrollment purposes. W grades are received when students officially withdraw from a course after the drop/add period. X grades are received for audit credit.



Students completing work for a course in which they received an I grade must maintain continuous enrollment as defined previously.

## Request to maintain continuous enrollment (leave of absence)

Graduate students planning to discontinue registration for a semester or more must submit a **Leave of Absence request via their Interactive Plan of Study (iPOS).** This request must be submitted and approved before the anticipated semester of non-registration. Students may request a maximum of two semesters of leave during their entire program. Having an approved Leave of Absence by the Graduate College will enable students to re-enter their program without re-applying to the university.

Students who do not register for a fall or spring semester without an approved Leave of Absence are considered withdrawn from the university under the assumption that they have decided to discontinue their program. Students removed for this reason may re-apply for admission to resume their degree program; the application will be considered along with all other new applications to the degree program.

Students with a Graduate College approved **Leave of Absence** are not required to pay tuition and/or fees, but in turn are not permitted to place any demands on university faculty or use any university resources. These resources include university libraries, laboratories, recreation facilities or faculty and staff time. For more information see <u>Graduate College Policies</u>.

## Voluntary withdrawal

To withdraw from a graduate program and the university, students must complete the <u>Voluntary Withdrawal form</u>. Submitting a voluntary withdrawal form does not remove a student from courses. Students must file separately with the University Registrar's Office to drop any courses.

## Medical/compassionate withdrawal

A student may be eligible for a medical/compassionate withdrawal if the withdrawal is due to extenuating circumstances such as a previous serious physical or mental illness (medical withdrawal) or the death or serious illness of a family member (compassionate withdrawal). To request a medical or compassionate withdrawal, students must submit a Request for a Documented Medical/Compassionate Withdrawal.

## Appeal and grievance processes

#### Academic probation

There is no appeal from the action of being placed on probation. Probation provides a warning to the student of the potential for suspension and/or dismissal.

## Grade appeal procedure

Final, official course grades are listed on My ASU via the student's transcript. Students should check their transcripts regularly following the grade posting date for each term. In the event there is a discrepancy between the final grade in the transcript and the grade the student expected to receive based on the Canvas gradebook, students must submit an appeal to the instructor within 10 business days of the last date for posting final grades, as listed in the <u>Academic Calendar</u>, and according to the appeal process outlined below:

**Reasons for grade appeal**: A student may appeal a grade only when they can document that one or a combination of the following has occurred:



- The instructor erred in calculating points or acknowledging timely submission of assignments.
- The instructor did not apply grading standards equitably (that is, there is evidence of bias; for example, due to race, age, sex, religion or national origin).
- The instructor did not assign grades consistent with the standards and procedures for evaluation announced at the beginning of the course in the course syllabus. The instructor may amend or supplement the standards and procedures during the course by providing written or oral notice to the entire class.

Step 1: Informal meeting with instructor — This step is mandatory and applies only to appeal of course grades.

- The student must contact the instructor of the course and complete and submit the <u>Grade Appeal Form</u>.
  The student must provide any additional relevant documentation to support the appeal and reasons for disputing the grade to the instructor. The narrative accompanying the appeal form may not exceed five double-spaced pages.
- 2. The student must meet with the instructor either face-to-face or, in the case of online classes only, virtually. If this meeting does not resolve the grievance, the student may move to step 2 and submit the Grade Appeal Form to the Office of Academic and Career Success.

Note: If the required meeting with the instructor has not taken place, the appeal will be accepted only if the student supplies evidence that they contacted the instructor and, A) received no reply for five business days, or B) have been unable to schedule a meeting within 10 business days of the date of contact.

**Step 2: Submit grievance to Office of Student Services** — If the grievance is not resolved in step 1, the student may forward the grade appeal to Erica Mitchell, executive director of student services, at <a href="mailto:erica.mitchell@asu.edu">erica.mitchell@asu.edu</a>.

**Step 3: Division director reviews grade appeal** — The executive director of student services will review the grade appeal and may request additional information. The grade appeal will be forwarded to the division director for review, if the appeal meets the criteria for a grade appeal. The division director will review all information and notify the student of the outcome.

## Step 4: Appeal decision to the dean

- Per ASU policy, the student may appeal the division director's decision to the dean, whose decision is final. The student must appeal within five business days of receiving the division director's decision.
  - To submit an appeal to the dean, the student must forward the original appeal and the division director's response to the Director of Academic Operations Alana Lackore at Alana.Lackore@asu.edu , who will begin the appeal process at the dean's level.
- Only the issue appealed to the division director may be appealed; no new issues or complaints may be added. The dean or her designee has full discretion as to whether to refer the appeal to the Student Issues Committee (also known as the College Academic Grievance Committee). See <u>University Policy for</u> Student Appeal Procedures on Grades.
- The student will be notified by mail of the outcome. The decision of the Student Issues Committee (dean's designee) is final.

**Deadline:** To receive consideration, the appeal form and supporting documentation must be submitted to the instructor within 10 business days of the last date for "Final grades due" as listed in the <u>Academic Calendar</u>.

**Submit Form:** Submit a <u>Grade Appeal Form</u> to your instructor when requesting a meeting. Both undergraduate and graduate students should also submit a copy to <u>erica.mitchell@asu.edu</u>. Your email will count as an electronic signature.

It is ASU's policy that students filing grievances and those who are witnesses are protected from retaliation. Students who believe they are victims of retaliation should immediately contact the dean of the college in which the course is offered. More information on ASU grading policies



During the time of the appeal, a student may register for courses; however, if the appeal is denied and the student is withdrawn, ASU's policies on tuition refunds will be applied. Any concerns about tuition charges should be addressed to the Registrar's Office.

## Appealing a recommendation for dismissal from program

The Graduate College admits students to graduate study at ASU. Students who fail to make satisfactory academic progress may be involuntarily withdrawn (dismissed) from their academic programs by the Graduate College upon the recommendation of MLFTC. The student has the right to appeal a recommendation for dismissal.

#### Steps in the appeal process:

- 1. The student receives notice from the executive director of student services that a recommendation for dismissal from the program is being made to the ASU Graduate Education office.
- 2. Within 10 business days of receiving this notice, the student may appeal in writing to the appropriate division director on the MLFTC Student Issues Committee (dean's designee). Petitions for review forms are available in the MLFTC Office of Student Services on each campus. Failure to file the appeal within 10 business days of the date of notification will result in an automatic denial of the appeal.

## Maximum time limit to complete degree

**Master's degree** — All work toward a master's degree must be completed within six consecutive years. The six years begin with the semester and year of admission to the program. Graduate courses taken prior to admission that are included on the plan of study must have been completed within three years of the semester and year of admission to the program.

**Doctoral degree** — Doctoral students must complete all program requirements within a 10-year period. The 10-year period begins with the semester and year of admission to the doctoral program. Graduate courses taken prior to admission that are included on the iPOS must have been completed within three years of the semester and year of admission to the program. (Previously awarded master's degrees used on the plan of study are exempt.)

Any exception to the time limit policy must be approved by the supervisory committee, the head of the academic unit and the dean of the Graduate College. The Graduate College may withdraw students who are unable to complete all degree requirements and graduate within the allowed maximum time limits.
