Requirements and Next Steps

- **Maintain 2.25 cum GPA** and successfully complete course work each semester.
- **Obtain DPS Identity Verified Print (IVP) Fingerprint Clearance Card**
 State law requires students have an **IVP** card to participate in internship and student teaching experiences. Online application can be accessed here: www.azdps.gov/services/fingerprint
 Be sure to select **IVP** fingerprint card - **State Board of Education (Teacher Certification)** on application. Employment information can be left blank. Electronic fingerprinting is recommended over paper. You must be in AZ for this method.
Once you receive your IVP card in the mail – upload a copy of both sides here: bit.ly/ivpcard.
- **Watch for email communication** from **Teachers College** about our *Satisfactory Academic Progress and Professional Conduct Policy (SAPP)*, which will include information on how to progress academically and professionally in the program. SAPP Policy: <https://education.asu.edu/mymlftc/student-forms-policies>
Once you have reviewed and submitted the acknowledgment form, you will receive email communications from the Professional Education Services office.
- **The Professional Education Services office (PES)** in Teachers College will be responsible for finding an appropriate internship placement in a 6-12th grade classroom for you. Be sure to **submit any required documents, including SONIA form**, when requested to avoid delays in the placement process.
 - Your internships require a minimum of 45 classroom hours each.
 - In your final semester, you will complete a **student teaching residency** which requires a full-time commitment over the entire semester.
- **When enrolling in education courses, be sure to look for courses with reserves for Secondary Education (which includes fine arts)**. You will not have permission to enroll in TEL courses with reserves for Early Childhood, Elementary Education, or Special Education students.

Additional Certification Requirements:

IMPORTANT Certification Exam(s):

Art students will be required to pass either the **Elementary** or **Secondary Professional Knowledge Exam** to obtain their teaching credential.

Art students satisfy the **subject knowledge requirement** with their degree in Art Education.

We encourage students to research Arizona school districts for their hiring preferences or recommendations, which may include possible subject knowledge exam(s).
