The Mary Lou Fulton Teachers College at Arizona State University is seeking two (2) part-time (.51% FTE) Instructors of educational leadership. The successful candidate will teach online and/or hybrid courses and mentor doctoral students in an education doctoral program. The candidate will have opportunities to collaborate with nationally recognized faculty in research and educational leaders in innovation and program development.

The Doctor of Education (EdD) in Leadership and Innovation in the Mary Lou Fulton Teachers College at Arizona State University (ASU) is an award-winning program and member of the Carnegie Project on the Educate Doctorate (CPED). The program prepares students, among other things, for conducting action research and to be educational leaders in PK-12 settings, higher education settings and other educational settings. It is designed for practicing educator-leaders who work in a range of settings and want to transform and better their practice and create better learning opportunities for students of all ages. Students in the program begin as accomplished teachers, teacher leaders, principals, superintendents, higher education professionals, or leaders in other educational contexts working to implement change in their local place of practice. Through coursework, students deepen their abilities to lead change and implement innovation in their local educational organizations. The three-year program is offered in two formats, hybrid and online, with both offerings sharing similar coursework and structure.

This is a part-time (51% FTE), benefits-eligible academic year (9-month) position that begins **December 26, 2022**. The faculty members in the Division of Educational Leadership & Innovation are dedicated to producing educational leaders, community advocates, researchers, and university faculty with the knowledge, dispositions, and skills that will result in more equitable and inclusive educational systems through transformative frameworks and social justice pedagogies.

Essential Duties:

Major responsibilities include (1) teaching graduate courses in the Ed.D program in Leadership and Innovation, (2) assisting in online and hybrid course development for the Ed.D program; (3) serving as dissertation-in-practice chair; (4) mentoring doctoral students; (5) providing service to the program and college.

Required Qualifications:

- Earned doctorate from an accredited university in educational leadership, education or a related field by the start date of appointment
- Experience teaching graduate and doctoral level including online teaching

Desired Qualifications:

- Experience with action research or other methodologies used in dissertations in practice
- Experience mentoring students in an education doctorate program
- Experience creating online courses
- Experience and commitment to research and teaching with a focus on social embeddedness, educational equity, social justice, or global engagement.
- Prior experience in higher education, PK-12, or other educational setting
- Experience with teaching and supporting student writing
- Scholarly accomplishments appropriate to this stage in an academic career
