We seek an individual with a strong research program in special education and teacher education, with expertise in facilitating access to the general education curriculum through evidence-based practices for diverse students with disabilities. The successful candidate understands the broader field of special education and has a strong interest in and commitment to both research and educator preparation. The successful candidate will help to provide overall direction for the research agenda for teacher preparation programs and faculty leadership consistent with the goals and organization of the college. The successful candidate will also advance [ASU's Design Aspirations](#) through research, teaching, and service and will effectively work with culturally, ethnically, and linguistically diverse populations.

Required Qualifications:

- Earned doctorate in special education or related field, by the start date of appointment;
- Established record or evidence of strong potential for scholarly productivity through a line of research that leads to a competitive record of scholarship, research, and external funding, commensurate with career stage;
- Established record or evidence of strong potential of successful teaching and mentoring of students in teacher preparation and leadership, commensurate with career stage;
- Evidence of successful educational experiences supporting PK-12 students with disabilities and their families.

Desired Qualifications:

- Established record or evidence of strong potential to form collaborative partnerships with community programs, schools, relevant state departments, professional organizations, families, and/or others serving children or youth with disabilities and their families;
- An established grant writing track record with experiences as a principal investigator or co-investigator, and experience acquiring external funding for research
- A demonstrated commitment to diversity and equity in education through scholarship, teaching, and/or service;
- Demonstrated evidence of three years' experience teaching children with and/or at-risk for disabilities in PK-12 settings and in the provision of specialized, systematic instruction;
- Demonstrated ability to design, develop, and teach in-person, synchronous, and online courses in teacher preparation using research-based practices.

This is a benefits-eligible, academic year (9-month) position, tenure-track faculty position in the Division of Teacher Preparation that begins August 15, 2023.
