

# Clinical Assistant Professor in Early Childhood Studies #112471

## Mary Lou Fulton Teachers College Division of Educational Leadership and Innovation

ASU's Mary Lou Fulton Teachers College (MLFTC) and the Division of Educational Leadership and Innovation invite applications for a clinical assistant professor in early childhood studies. The Early Childhood Studies program in the MLFTC prepares students for careers working with or on behalf of young children birth to age 5, not yet in Kindergarten. This program focuses on child development and best practices in early childhood settings (birth to age five, not yet in kindergarten), including the skills to design inclusive learning environments, planning, and facilitation of learning and development through relationships with children and families, teacher-child interaction, and family-centered practice.

The position includes teaching online, creating course content, providing feedback on student work/assignments, managing course materials in Canvas (learning management system), establishing supportive relationships with students, and service to the college. The Early Childhood Studies program welcomes applications from candidates who can bring a diversity of thought from their personal experiences with race, ability, gender, language, etc. The successful candidate will also advance <u>ASU's Design Aspirations</u> through teaching and service and effectively work with culturally, ethnically, and linguistically diverse populations.

#### **Essential Duties:**

- Delivering instruction in online courses, including synchronous and asynchronous instruction, providing timely
  and actionable feedback on student assignments, managing course materials in Canvas (learning management
  system for the college), and utilizing technology tools to support student engagement (e.g., Zoom, Slack,
  Yellowdig).
- Establishing and maintaining warm and responsive relationships with students through facilitating course experiences and when engaging with students via office hours, emails, and meetings.
- Collaborating with colleagues and other professionals to ensure effective instruction for students throughout their program
- Developing course curricula and content and curating course materials aligned with program-level outcomes.
- Providing service to the program, division, college, and/or university through a variety of mechanisms, such as
  acting as a course coordinator in charge of collaborating with full-time and part-time faculty, maintaining, redeveloping, and designing course materials, developing new courses, and content, related to early childhood
  workforce needs, serving on a college or university committee, or other related service activities.

#### Required Qualifications [minimum requirements needed to fulfill the duties]

- Master's Degree in Early Childhood Education, Curriculum and Instruction, Child Development, Family Studies, or a closely related field (degree must be awarded by the start date)
- 5+ years of teaching children birth to age 5, not yet in kindergarten, or working directly with families, schools, or organizations that provide services to families and children birth to age 5, not yet in kindergarten.
- 3+ years of teaching courses or content to adult learners on topics related to early childhood such as child development, family studies at community college, university-level post-secondary, or other adult education settings.

### Desired Qualifications: [further refinement of duties for the position]

- Earned Ph.D. or Ed.D. in Early Childhood Education, Curriculum and Instruction, Child Development, Family Studies, or a closely related field
- 1+ years' of experience teaching adult learners using an online learning management system such as Canvas or Blackboard
- Evidence of experience with and/or certification in early childhood classroom/in-home evaluation tools such as CLASS, ECERS, ITERS, and/or FCERS.



- Engagement in early childhood and/or early intervention professional organizations (e.g., DEC, NAEYC, Zero to Three, ITMHCA)
- 1+ years' experience working collaboratively with shared stakeholders in birth to five early childhood programs (e.g., quality first, coaching, first things first)
- 1+ years' experience providing formative feedback on adult-child interactions in birth to five early childhood settings.
- Evidence of course/curriculum development of early childhood content (birth to age five, not yet in kindergarten) for community college, university-level post-secondary, or other adult education settings.
- 1+ years' experience leading collaborative team environments
- 1+ years' experience serving students with diverse experiences, abilities, and backgrounds
- Understanding (e.g., coursework, professional development, training) of issues of equity (racial, dis/ability) in educational contexts
