

Faculty Associate, Professional Learning Pool Position #114642

ASU's Mary Lou Fulton Teachers College (MLFTC) invites applications to establish a pool for Faculty Associates in Professional Learning for the 2023-2024 academic year. The successful candidate(s) will teach in-person, hybrid, or online courses, prepare course materials, evaluate student work, provide effective feedback, guide and assist students, and post final grades for professional learning courses. Mary Lou Fulton Teachers College welcomes applications from candidates who can bring diversity of thought from their personal experiences with race, ability, gender, language, etc.

Our programs bring people and ideas together to increase the innovation capabilities of individual educators, schools and organizations, districts and communities. MLFTC is building the [Next Education Workforce](#) which starts with the conviction that, if we're not getting the workforce or the learning outcomes we want, we need to redesign the profession, the workplace and how we prepare people for both. As such, the Mary Lou Fulton Teachers College, partners with schools and organizations to:

1. Provide all students with deeper and personalized learning by building teams of educators with distributed expertise; and
2. Empower educators by developing new opportunities for role-based specialization and advancement

Faculty Associate positions are one semester (assignments will vary between 2 - 15 weeks), non-benefits-eligible, and fixed-term appointments with no tenure implications, not to exceed .40 FTE. Professional learning courses are generally 4-8 weeks in length, but there may be some variation. The number of courses is contingent upon needs, funding, and sufficient enrollment. Individuals hired as Faculty Associates may not hold multiple, non-benefits-eligible appointments at Arizona State University. Salary is based upon qualifications and assigned teaching load.

This recruitment is to establish a part-time hiring pool for temporary and semester appointments. Applications are considered for the current year only. Applicants who are not hired are encouraged to reapply for the next posting.

The position serves as a lead instructor and includes teaching during class times (for synchronous courses) or online through managing the course shell in Canvas CPE (learning management system), preparing course materials, discussion participation, providing effective feedback, grading, and establishing warm and supportive relationships with students through class, office hours, emails, and meetings, as needed. Further, for professional learning courses, collaboration with the instructional design team to make updates or needed changes to the course when necessary.

Required Qualifications:

- Master's degree in education-related field, with focus on content area of expertise
- 3+ years of teaching or related experience

Desired Qualifications:

- At least one semester of experience teaching at the university-level post-secondary or other adult education setting (including professional learning)
- Evidence of expertise in specified area(s) based on either classroom teaching, practice in educational contexts, and/or engagement in relevant professional learning
- Experience using course management systems such as Canvas and digital tools like Zoom
- Experience supporting the growth/development of other educators (i.e. facilitating professional learning, supervision, coaching, and/or team teaching)
