- To develop students' skills for facilitating learning experiences with and for diverse people in different contexts, skills to foster equity and inclusion, and skills for effective communication, collaboration, leadership, advocacy, and innovation

Essential Duties:

- Teaching: Delivering instruction in in-person and online classroom environments; providing timely and actionable feedback on student assignments; managing course materials in Canvas (learning management system for the college), and utilizing technology tools to support student engagement (e.g., Zoom, Slack, Yellowdig).
- Supporting Students: Establishing and maintaining positive, caring, and culturally responsive relationships with students through facilitating engaging, interactive, and supportive course experiences and providing additional support via office hours, emails, and meetings as necessary.
- Collaborating: Working with colleagues and other professionals to ensure effective learning and positive college experiences for students in the Educational Studies program
- Designing: Developing course curricula and content and curating course materials aligned with program-level outcomes.
- Serving: Providing service to the program, division, college, and/or university through a variety of mechanisms, such as acting as a course or program coordinator in charge of collaborating with full-time and part-time faculty, maintaining, re-developing, and designing course/program materials, developing new courses, and content, serving on a college or university committees, or other related service activities.

Required Qualifications:

- Master's Degree related to Education, Social, Cultural, and Behavioral Science, Humanities, Business, or a field that promotes learning, innovation, and change (degree must be awarded by the start date)
- 5+ years of experience in formal (PreK-higher education), informal (e.g., museums, community organizations), or corporate (e.g., education consulting, corporate training) educational settings working with learners of any age (birth-adult)

Desired Qualifications:

- Evidence of professional experience with learning contexts outside of PreK-12 classrooms, including (but not necessarily limited to) museums, teaching and learning centers, adult literacy/citizenship/ESL classes, corporate training, community-based organizations, youth organizations, and camps.
- Evidence of experience and or content expertise connected to one or more [Education Studies Course\(s\)](#)
- Evidence of successful teaching at the post-secondary level (e.g., at community college, university-level post-secondary, or other adult education settings).
- Demonstrated success in developing, maintaining, and teaching online course content (asynchronously and/or synchronously).
- Evidence of success in leadership or administrative roles.
- Earned Ph.D. or Ed.D. in Education, Social, Cultural, and Behavioral Science, Humanities, Business, or a field that promotes learning, innovation, and change (degree must be awarded by the start date).
- Substantive specialization in areas of human development related to learning.
- Demonstrated commitment to values expressed by the [ASU Charter](#).
