The successful candidate will lead undergraduate and graduate students through inquiry-based field science investigations and teach a variety of topics such as climate change, natural history, geology, urban ecology, biomimicry, resource management, and the cultural history of the US Southwest. The successful EE candidate will build and teach courses for the environmental education certificate program and assist with Certificate course development, revisions, and the development and implementation of an EE Study Abroad experience.

The position includes teaching in a variety of environments, which may include classroom, community/professional experiences, or distance/online, creating course content, providing feedback on student work/assignments, managing course materials in Canvas (learning management system), establishing supportive relationships with students, and service to the college.

The Division of Educational Leadership and Innovation welcomes applications from candidates who align with ASU's charter and are committed to inclusive excellence and student success. The successful candidate will also advance [ASU's Design Aspirations](#) through teaching and service.

Essential Duties: Delivering instruction, in a variety of environments, which may include classroom, community/professional experiences, or distance/online, providing timely and actionable feedback on student assignments, managing course materials in Canvas (learning management system for the college), and utilizing technology tools to support student engagement (e.g., Zoom, Slack, Yellowdig).

- Establishing and maintaining warm and responsive relationships with students through facilitating course experiences and when engaging with students via office hours, emails, and meetings.
- Collaborating with colleagues and other professionals to ensure effective instruction for students throughout their program.
- Developing course curricula and content and curating course materials aligned with program-level outcomes.
- Providing service to the program, division, college, and/or university through a variety of mechanisms, such as acting as a course coordinator in charge of collaborating with full-time and part-time faculty, maintaining, re-developing, and designing course materials, developing new courses, and content, related to educational foundations workforce needs, serving on a college or university committee, or other related service activities.

- Ph.D. or Ed.D. in Education, Environmental Education, Environmental Sciences, Environmental Studies, Sustainability, or a closely related field (degree must be awarded by the start date)
- 2+ years of relevant college teaching experience

- Evidence of successful course or curriculum development of environmental science and/or environmental education content for community college, university-level, post-secondary, or other adult education settings (such as leading professional learning).
- Evidence of successful teaching of inquiry-based field science investigations with a variety of topics such as climate change, natural history, geology, urban ecology, biomimicry, resource management, or the cultural history of the US Southwest.
- Evidence of sustained engagement with environmental or sustainability education professional organizations and/or agencies.
- Environmental education certification.
