The Mary Lou Fulton Teachers College invites applications for the position of Instructor to teach and develop courses for the Undergraduate Educational Studies program at Arizona State University. The successful candidate will have an established record of teaching (online and in person) at the university level, developing courses for both in-person and online delivery, and facilitating instructional teams. Candidates should also have experience collaborating with faculty and staff within college or university institutions. Consistent with our program's aims, we enthusiastically invite applicants whose work exemplifies justice, equity, diversity, and inclusion within and/or beyond educational contexts. The Instructor's major responsibilities will include: (1) teaching in-person and online courses in the Educational Studies program; (2) developing course content and working with instructional designers to create courses in Canvas; (3) facilitating instructional teams for online courses; (4) collaborating with program faculty.

This is a full-time, benefits-eligible, academic year (9-month) appointment to begin August 16, 2022. Subsequent one-year appointments may be offered, under the same terms and conditions, at the discretion of the university. Fixed-term appointments have no tenure implications and do not accrue time towards sabbatical.

Essential Functions

- Teach 5 undergraduate courses, a mix of in-person and online, per semester in the Educational Studies program
- Develop course content, including creating courses in Canvas

Required Qualifications

- Master's Degree related to Education, Social, Cultural, and Behavioral Science, Humanities, Business, or a field that promotes innovation, learning, and change (e.g., Sustainability, Business, Engineering).
- Five or more years of teaching, mentoring, coaching, or related experience working with learners of any age (Birth-adult)
- 2 years or more teaching and/or designing online and/or in-person courses at the university level

Desired Qualifications

- Three or more years of successful instructional experience at the university level
- Experience and or content expertise connected to one or more [Educational Studies Course\(s\)](#)
- Experience leading instructional teams
- Experience using learning management systems (e.g. Canvas, Blackboard, Google Classroom).
- Entry-level understanding or training in justice, diversity, equity, and inclusive teaching



- Experience with learning contexts outside of PreK-12 classrooms (e.g. youth organizations, camps, museums, teaching and learning centers, adult literacy/citizenship/ESL classes, community-based organizations)
